APPROVAL OF AGENDA: MOTION TO APPROVE THE JANUARY 4, 2017 REGULAR MEETING AGENDA WITH NO CHANGES WAS MADE BY BRAD STAFFORD AND SECONDED BY ERNEST JOHNSON. THOSE IN FAVOR OF THE MOTION WERE BRAD STAFFORD, LUCIUS HOLLOWAY, ERNEST JOHNSON AND CRIS WEBB. MOTION CARRIED.

APPROVAL OF MINUTES: MOTION TO APPROVE THE MINUTES OF THE DECEMBER 7, 2016 REGULAR MEETING WITH NO CHANGES WAS MADE BY ERNEST JOHNSON AND SECONDED BY BRAD STAFFORD. THOSE IN FAVOR OF THE MOTION WERE BRAD STAFFORD, LUCIUS HOLLOWAY, ERNEST JOHNSON AND CRIS WEBB. MOTION CARRIED.

QUESTIONS ON PRIOR MINUTES: NO QUESTIONS

ELECTION OF COUNTY COMMISSION OFFICERS FOR 2017: VICE CHAIRMAN—THE MOTION TO CONTINUE THE ROTATION OF COMMISSIONERS BY DISTRICT FOR THE VICE CHAIRMAN SEAT OF THE BOARD, WHICH WILL BE ERNEST JOHNSON OF DISTRICT 2, WAS MADE BY BRAD STAFFORD. LUCIUS HOLLOWAY GAVE THE SECOND. THOSE IN FAVOR OF THE MOTION WERE BRAD STAFFORD, LUCIUS HOLLOWAY, CRIS WEBB, AND ERNEST JOHNSON. THE MOTION CARRIED. PURCHASING—ERNEST JOHNSON MADE THE MOTION FOR BRAD STAFFORD TO CONTINUE AS COMMISSIONER FOR PURCHASING AND LUCIUS HOLLOWAY GAVE A SECOND. ALL IN FAVOR OF THE MOTION WERE ERNEST JOHNSON, LUCIUS HOLLOWAY, CRIS WEBB, AND BRAD STAFFORD. THE MOTION CARRIED. PROPERTY—LUCIUS HOLLOWAY MADE THE MOTION FOR ERNEST JOHNSON TO CONTINUE AS COMMISSIONER FOR PROPERTY AND CRIS WEBB GAVE THE SECOND. ALL IN FAVOR OF THE MOTION WERE LUCIUS HOLLOWAY, BRAD STAFFORD, CRIS WEBB, AND ERNEST JOHNSON. THE MOTION

CARRIED. CHAPLAIN— THE MOTION WAS MADE BY LUCIUS HOLLOWAY FOR CRIS WEBB TO CONTINUE AS CHAPLAIN. ERNEST JOHNSON GAVE A SECOND. ALL IN FAVOR OF THE MOTION WERE LUCIUS HOLLOWAY, ERNEST JOHNSON, BRAD STAFFORD, AND CRIS WEBB. THE MOTION CARRIED.

SET COMMISSIONERS' SALARIES FOR 2017: ERNEST JOHNSON MADE A MOTION TO HAVE THE SALARIES REMAIN THE SAME AS PREVIOUS YEAR WHICH IS \$300.00 PER MONTH FOR NON CERTIFIED COMMISSIONERS, AND \$400.00 PER MONTH FOR CERTIFIED COMMISSIONERS, AND \$600.00 FOR THE CHAIRMAN. BRAD STAFFORD GAVE THE SECOND. ALL IN FAVOR OF THE MOTION WERE ERNEST JOHNSON, LUCIUS HOLLOWAY, CRIS WEBB, AND BRAD STAFFORD. THE MOTION CARRIED.

HIRE COUNTY ATTORNEY FOR 2017: CHAIRMAN GAMBLE STATED THAT ED COLLIER SERVING AS COUNTY ATTORNEY WOULD BE A CONFLICT OF INTEREST AND SUGGESTED TABLING THIS MATTER SO THAT THE BOARD COULD HAVE MORE TIME TO CHECK INTO PROSPECTS FOR HIRING AND SALARY TO OFFER. A MOTION TO TABLE THIS ITEM ON THE AGENDA WAS MADE BY LUCIUS HOLLOWAY AND BRAD STAFFORD GAVE A SECOND. ALL IN FAVOR OF THE MOTION WAS BRAD STAFFORD, LUCIUS HOLLOWAY, CRIS WEBB, AND ERNEST JOHNSON. THE MOTION TO TABLE CARRIED.

SET PLANS FOR FILLING POSITION IN COMMISSIONERS' OFFICE: THE CHAIRMAN OPENED THIS ITEM TO THE COMMISSIONERS FOR DISCUSSION. BRAD STAFFORD STATED HE FAVORED THE OPTION OF HAVING A COUNTY MANAGER WITH NO CHANGES IN THE CURRENT OFFICE CLERICAL STAFF. LUCIUS HOLLOWAY SAID HE LEANED TOWARD THE COUNTY MANAGER AS WELL FOR HE BELIEVED THIS WOULD ACCELERATE THE FUTURE GROWTH OF TERRELL COUNTY. ERNEST JOHNSON STATED THE SAME AS MR. HOLLOWAY. CRIS WEBB ASKED CHAIRMAN GAMBLE HOW MUCH OF A ROLE WOULD HE HAVE IN MANAGING THE COUNTY. COMMISSIONER WEBB STATED HE BELIEVED A MANGER WOULD BE ABLE TO WRITE GRANTS TO OBTAIN MONIES THAT ARE KNOWN TO BE AVAILABLE AT THIS TIME FOR COUNTIES; ESPECIALLY IN THE MATTER OF ROADS. CHAIRMAN GAMBLE STATED HE PLANS TO BE ACTIVE IN ALL MATTERS OF THE COUNTY. HE STATED THAT HE NEEDS TIME TO SETTLE IN AS CHAIRMAN AND THE COMMISSIONERS' OFFICE ROUTINES. HE ALSO STATED HE LIKED THE OFFICE STATUS AND CURRENT STAFF AS IS. MR. GAMBLE SUGGESTED THAT THIS ITEM BE TABLED AND BROUGHT BACK TO THE FEBRUARY MEETING. BRAD STAFFORD MADE THE MOTION TO TABLE THIS MATTER AND CRIS WEBB GAVE A SECOND. THOSE IN FAVOR OF THE MOTION WERE BRAD STAFFORD, CRIS WEBB, ERNEST JOHNSON, AND LUCIUS HOLLOWAY.

SET UP ORDER OF BUSINESS: <u>DEADLINES</u>.-ERNEST JOHNSON MADE A MOTION FOR THE DEADLINE TO PLACE ITEMS ON THE AGENDA TO REMAIN AS NOON ON THE FRIDAY PRIOR TO THE COMMISSIONERS' MEETING DATE. LUCIUS HOLLOWAY GAVE THE SECOND. ALL IN FAVOR OF THE MOTION WERE ERRNEST JOHNSON, LUCIUS HOLLOWAY, CRIS WEBB, AND BRAD STAFFORD. THE MOTION CARRIED. <u>NUMBER OF TIMES TO PRESENT SAME ITEMS</u>.- COMMISSIONER HOLLOWAY STATED HE WAS OF THE OPINION ITEMS COULD BE BROUGHT BEFORE THE BOARD AS MANY TIMES AS NECESSARY IN ORDER TO BETTER SERVE THE CITIZENS; BUT MAYBE LIMIT THE TIME TO SPEAK TO THREE (3) MINUTES. COMMISSIONER STAFFORD STATED HE WAS IN FAVOR OF SETTING THE TIME LIMIT TO FIVE (5) MINUTES. COMMISSIONER JOHNSON MADE A MOTION TO SET THE TIME TO ADDRESS THE BOARD ON MATTERS TO FIVE (5) MINUTES WITH AN OPEN END OF NO RESTICTIONS ON THE NUMBER OF

TIMES AN ITEM CAN BE PRESENTED. COMMISSIONER WEBB QUESTIONED THE MOTION STATING HE WANTED TO HAVE RESTRICTIONS ON THE NUMBER OF TIMES TO PRESENT THE SAME ITEM. BRAD STAFFORD STATED HE THOUGHT THREE (3) MONTHS IN A YEAR'S TIME WOULD BE SUFFICIENT. CRIS WEBB AGREED. LUCIUS HOLLOWAY RESTATED THAT HE THOUGHT THERE SHOULD BE NO LIMITS TO NUMBER OF TIMES FOR CITIZENS MAY CONTINUE TO DISCOVER INFORMATION TO BRING BACK TO THE BOARD REGARDING A MATTER. MR. JOHNSON AMENDED HIS ORIGINAL MOTION TO STATE THE SAME ITEMS CAN BE BROUGHT BEFORE THE COMMISSIONERS THREE (3) TIMES IN A TWELVE (12 MONTH PERIOD AND THE DISCUSSION LIMITED TO FIVE (5) MINUTES. CRIS WEBB GAVE THE SECOND. ALL IN FAVOR OF THE MOTION WERE CRIS WEBB, ERNEST JOHNSON, BRAD STAFFORD, AND LUCIUS HOLLOWAY.

CHAIRMAN'S REPORT: WILBUR T. GAMBLE, III THANKED EVERYONE FOR THEIR ATTENDANCE AND INTEREST IN THE COUNTY COMMISSIONERS' MEETING. AT THIS TIME, CHAIRMAN GAMBLE RECOGNIZED FORMER TAX COMMISSIONER PEGGY PRITCHARD AS BEING THE SECOND LONGEST CONSTITUTIONAL OFFICER WHO SERVED TERRELL COUNTY. HE MADE A REQUEST TO HAVE CHARLENE FARMER ORDER A PLACQUE NOTING HER YEARS OF SERVICE. A MOTION TO HAVE A PLACQUE PURCHASED TO HONOR MRS. PRITCHARD WAS MADE BY ERNEST JOHNSON AND SECONDED BY BRAD STAFFORD. ALL IN FAVOR OF THE MOTION WERE ERNEST JOHNSON, BRAD STAFFORD, CRIS WEBB, AND LUCIUS HOLLOWAY. THE MOTION CARRIED.

TREASURER'S REPORT: PHONSO DONALDSON PRESENTED THE TREASURER'S REPORT FOR DECEMBER 2016. MOTION TO APPROVE THE DECEMBER 2016 TREASURER'S REPORT WAS MADE BY ERNEST JOHNSON AND SECONDED BY BRAD STAFFORD. THOSE IN FAVOR OF THE MOTION WERE BRAD STAFFORD, LUCIUS HOLLOWAY, ERNEST JOHNSON AND CRIS WEBB. MOTION CARRIED.

CLERK'S REPORT: BANK BALANCES AND EXPENDITURES FOR THE MONTH OF DECEMBER 2016 AND VENDOR ACTIVITY AND FUEL REPORTS WERE PRESENTED BY SANDRA O'STEAN. THE FACT THAT THE COUNTY AUDIT HAD BEEN COMPLETED AND PUBLISHED WAS STATED. COPIES OF THE AUDIT WERE AVAILABLE TO ALL COMMISSIONERS AND TO THE PUBLIC.

EMS-911 REPORT: BO HAMBY REPORTED FOR THE MONTH OF DECEMBER 2016, 911 ANSWERED A TOTAL OF 562 CALLS, 192 EMS RELATED, 113 PATIENTS TRANSPORTED, 79 PATIENTS NOT TRANSPORTED, 63 CALLS FOR TERRELL COUNTY SHERIFF'S DEPARTMENT, 76 CALLS FOR DAWSON POLICE DEPARTMENT, 2 CALLS FOR DAWSON FIRE DEPARTMENT, 9 CALLS FOR TERRELL COUNTY FIRE DEPARTMENT, 220 CALLS FOR PUBLIC ASSISTANCE AND A TOTAL OF \$ 24,298.45 WAS DEPOSITED FOR THE MONTH OF DECEMBER 2016.

EXTENSION SERVICE: SETH MCALLISTER PRESENTED A SCHEDULE OF EXTENSION PRODUCTION MEETINGS AND STATED THE IMPORTANCE OF GROWERS ATTENDING AS THE EPD WOULD BE ENFORCING NEW RULES THIS YEAR. MARGARET HALBROOK GAVE AN UPDATE ON THE CLEAN UP PROJECT ONGOING AT THE 4H PAVILLION.

CHAMBER OF COMMERCE: LONDON MAINOR PRESENTED CALENDAR OF EVENTS THAT OCCURRED FOR DECEMBER 2016.

WARDEN'S REPORT: THERE WAS NO WARDEN'S REPORT.

ROAD SUPERVISOR'S REPORT: BILLY MCCLUNG DISCUSSED THE INVOICE TABLED FROM LAST MEETING WHICH WAS FROM YANCEY FOR REPAIRS TO CAT MOTOR GRADER. MR. MCCLUNG REPORTED THAT HE CONTACTED YANCEY AND THEY WOULD NOT CONCEDE ON THE CHARGES OF \$3,000.00 FOR REPAIR TO BUSHINGS WHICH WERE NOT PROPERLY GREASED. YANCEY MECHANIC HAD SERVICED THE MACHINE ABOUT ONE AND ONE HALF MONTHS AGO. COMMISSIONER BRAD STAFFORD STATED YANCEY WAS UNFAIR IN NOT TAKING RESPONSIBILITY FOR THE PROBLEM AND REPAIR AND SUGGESTED THE COUNTY DRAFT A LETTER TO YANCEY STATING THE COUNTY IS NOT TOTALLY RESPONSIBLE DUE TO THE SERVICE AGREEMENT THE COUNTY HAS WITH YANCEY. CHAIRMAN GAMBLE VOLUNTEERED TO WRITE A LETTER TO YANCEY AND ADVISED THAT THE INVOICE NOT BE PAID UNTIL A RESPONSE IS GIVEN. COMMISSIONER LUCIUS HOLLOWAY REMINDED THE BOARD THAT AT THE LAST MEETING HE DISAGREED WITH PAYING THE BILL. BRAD STAFFORD MADE A MOTION TO ALLOW THE CHAIRMAN TO WRITE YANCEY A LETTER ABOUT THE COUNTY'S CONCERNS AND TABLE THE PAYMENT OF THE INVOICE. ERNEST JOHNSON GAVE THE SECOND. ALL IN FAVOR OF THE MOTION WERE BRAD STAFFORD, ERNEST JOHNSON, LUCIUS HOLLOWAY, AND CRIS WEBB. THE MOTION CARRIED. BILLY MCCLUNG GAVE FEEDBACK THAT THE COMMITTEE APPOINTED TO LOOK AT BIDS FOR MOTOR GRADER AWARDED THE BID TO FLINT EQUIPMENT COMPANY FOR A JOHN DEERE AT \$1,852.00 PER MONTH LEASE.

WARDEN MCCLUNG ALSO REPORTED THAT DUE TO THE SEVERE WEATHER AND DAMAGES THAT OCCURRED IN CALHOUN COUNTY, INMATE WORK DETAILS WERE DISPATCHED TO LEARY, GEORGIA TO ASSIST IN CLEAN UP.

CHAIRMAN GAMBLE REQUESTED THAT A RETIREMENT PLAN BE PUT IN PLACE FOR THE TAX COMMISSIONER. ERNEST JOHNSON MADE A MOTION TO PLACE THE TAX COMMISSIONER IN A RETIREMENT PLAN WITH THE COUNTY CONTRIBUTING TO THE SAME. CRIS WEBB GAVE A SECOND. ALL IN FAVOR OF THE MOTION WAS ERNEST JOHNSON, CRIS WEBB, LUCIUS HOLLOWAY, AND BRAD STAFFORD. THE MOTION CARRIED. SUPERIOR COURT CLERK JANICE BRYANT ADDRESSED THE BOARD
